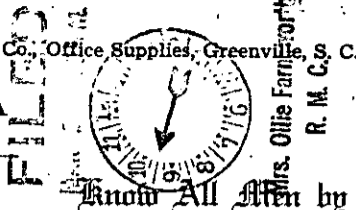

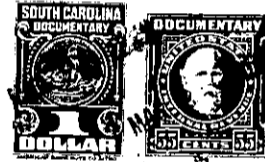

(the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Sam Wardlaw, his heirs and assigns, forever:

ALL that piece, parcel or lot of land being known and designated as lot 208 of subdivision known as Pine Forest as shown by a plat thereof, made by Madison H. Woodward, Engineer, said lot having the following metes and bounds:

BEGINNING at an iron pin on the southeast side of Pine Lake Circle at joint front corners of lots 209 and 208 and running S. 89-31 E. 278. 2 feet to an iron pin, joint rear corners of lots 209 and 208; thence with the rear line of lot 208 S. 28-10 W. 66.9 feet to an iron pin, joint rear corners of lots 208 and 207; thence with the common line of lots 208 and 207 N. 89-31 W. 224. 2 feet to an iron pin on Pine Lake Circle, joint front corners of lots 207 and 208; thence with the said Pine Lake Circle N. 20-10 W. 63.8 feet to an iron pin on Pine Lake Circle, the point of beginning.

GRANTEE herein to pay taxes for the year 1959.

Restrictions: The above described property is not to be sold, rented or otherwise disposed of to any Negro or person of African descent. No residence shall be erected on said lot costing less than Two Thousand (\$2000.00) Dollars. No residence shall be erected nearer than twenty-five (25) feet to the front line, and no residence shall be built on said lot unless it have fifty (50) feet or more frontage.



TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
