in consideration of the sum of Five Hundred and No/100 -- DOLLARS,

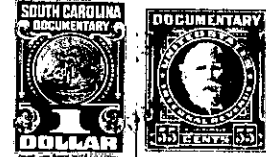

All that certain piece, parcel or lot of land lying and being in Austin township, Greenville County, State of South Carolina located on the south side of Forest Park Drive, being shown as the Western one-half of lot No. 80 in the subdivision known as Forest Park, plat thereof recorded in Plat Book "EE" at pages 64 and 65 in the Greenville County R. M. C. Office, and being more fully described as follows:

BEGINNING at an iron pin on the south side of Forest Park Drive at corner of lot No. 81 and running thence along said lot S. 21-59 E. 127 feet to an iron pin; thence N. 69-46 E. 45.35 feet to an iron pin; thence by a new line N. 21-59 W. 138.35 feet to an iron pin on Forest Park Drive; thence along said Drive S. 56-01 W. 46.4 feet to the beginning corner, and being a portion of the same lot conveyed to H. T. Leeke by Jeff R. Richardson, Trustee by deed recorded in Vol. 512 at page 357 in the Greenville County R. M. C. Office.
