ALL my right, title and interest in and to all that piece, parcel or tract of land, situate, lying and being in Saluda Township, Greenville County, State of South Carolina, located on the Northeast side of the Callahan Mountain Road being knownand designated as Lot 20 and the greater portion of Lot 21 on plat of the Property of R. G. Ballenger, made by Justice & Miller, Engineers, June, 1936, recorded in the RMC Office for Greenville County, S. C., in Plat Book "D", page 210, containing approximately 21 acres and having the following metes and bounds according to a recent survey by Dan.E. Collins, RLS, dated January 15, 1959:
