BEGINNING at an iron pin on the northern side of Range View Drive at the joint front corner of Lots Nos. 36 and 37, and running thence with the line of Lot No. 37, N. 38-30 W. 175 feet to an iron pin; thence N. 51-30 E. 200 feet to an iron pin at the joint rear corner of Lots Nos. 35 and 36; thence with the line of Lot No. 35, S. 10-38 E. 225.7 feet to an iron pin on the northern side of Range View Drive; thence with the northern side of Range View Drive, S. 73-30 W. 49 feet to a point; thence continuing with the northern side of Range View Drive, S. 58-52 W. 49.5 feet to the beginning corner.
