S. Highway No. 25); thence with Euncombe Road (U.S. Highway No. 25) N. 39-10 W. 80 feet to the point of beginning.

In addition to the taking of 25 feet from the front of said lot of the S. C. Highway Department has obtained an easement over an additional 25 feet on the front of said lot for beautification purposes, and this conveyance is made subject to said easement of the S. C. Highway Department.

The property herein conveyed is subject to restrictions recorded in Vol.425, page 500, RMC Office, Greenville County, incorporated herein by reference.
