BEGINNING at an iron pin on the Southwestern side of Windemere Drive at the joint front corner of Lots Nos. 35 and 36, and running thence with the line of Lot No. 35 S. 56-30 W. 175 feet to an iron pin; thence with the line of Lot No. 67 S. 33-30 E. 100 feet to an iron pin on the Northwestern side of Gail Avenue; thence with the Northwestern side of Gail Avenue N. 56-30 E. 150 feet to an iron pin at the curve of the intersection of Gail Avenue and Windomere Drive; thence with the curve of the intersection of Gail Avenue and Windemere Drive, the chord of which is N. 11-30 E. 35.3 feet to an iron pin on the Southwestern side of Windemere Drive; thence with the Southwestern side of Windemere Drive N. 33-30 W. 75 feet to the point of beginning.
