

BEGINNING at an iron pin on the Northeast side of State Highway No. 14 (formerly U. S. Highway No. 276) at the joint front corner of Lots 3 and 2; thence along the line of Lot 2 N. 53-54 E. 204.2 feet to an iron pin on the Northwest side of an unnamed County Road and the joint corner of Lot 3; thence along the line of Lot 3 S. 2-40 E. 144.45 feet to an iron pin; thence still with Lot 3 S. 212.4 feet to an iron pin at the interesection of said unnamed road the joint corner of Lot 3; thence continuing with the line of Lot 3 S. 53-00 W. 33.4 feet to an iron pin on the Northeast side of S. C. Highway No. 14; thence along the Northeast side of said highway N. 25-09 W. 298.4 feet to the beginning corner.
