CHARTER

WHEREAS,

did on the

9th

, day of

, 19 59, file with the Secretary of State a written Declaration,

signed by themselves, setting forth:

FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is TRINITY SMALL BUSINESS INVESTMENT COMPANY

THIRD: That the principal place of business is GREENVILLE, S. C.

FOURTH: That the general nature of the business which it is proposed to do is this corporation is organized and chartered expressly for the purpose of operating under the Small Business Investment Act of 1958 and will operate in the manner and shall have the powers, responsibilities and be subject to the limitations provided by said Act; and the regulations issued by the Small Business Administration thereunder.

FIFTH: That the amount of the capital stock is Five Hundred Thousand (\$500,000.00)------Dollars of which \$300,000.00 has been subscribed and is payable at the call of the board of directors in cash.

MINTEL: That all requirements of Title 12, Article 1, Chapter 2, Code of Laws of South Carolina, 1952, and all amendments thereto have been duly and fully complied with, 50 per cent, of the aggregate amount of the capital stock having been subscribed by bona fide subscribers, 20 per cent, of the capital stock subscribed having been paid to the Treasurer, and three days' public notice of the intention to file this Declaration with the Secretary of State having been given in Greenville News
