ALL that piece, parcel, or lot of land in the County of Greenville, State South Carolina, being known and designated as Division B of Lot 1, Section 2, Timberlake Subdivision, a plat of which is recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book BB, Page 184, and having according to a plat thereof recorded in said R. M. C. Office in Plat Book QQ.
