Know All Men by These Presents:

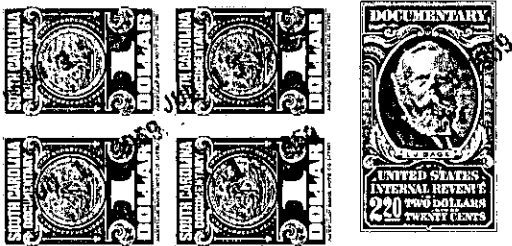
That I, T. A. Gilstrap, in the State aforesaid,
