T. SIMPSON,

All our right, title and interest, the same being an undivided two-thirds (2/3), in and to:

All that parcel or lot of land lying and being in the County of Greenville, State of South Carolina, being designated as Lot No. 41 as shown on Plat No. Three, Cherokee Forest, prepared by J. Mac Richardson, R.L.S., in January, 1959, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book QQ at pages 36 and 37, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin at the intersection of Vicki Circle and Roberta Drive, the joint corner of Lots Nos. 41 and 42 as shown on said plat, and running thence along Vicki Circle N. 7-11 E. 44 feet to an iron pin; thence N. 22-33 E. 43.4 feet; thence N. 55-32 E. 44.8 feet; thence N. 82-55 E. 31.7 feet; thence continuing along the Southern side of Vicki Circle N. 82-55 E. 100 feet, the joint corner with Lot No. 40; thence along the line of Lot No. 40 S. 2-27 E. 153.8 feet to an iron pin; thence N. 77-04 W. 200 feet to an iron pin, the point of beginning.
