CRADY S. HAYES AND FLORA K. HAYES:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Butler Township, being known and designated as Lot No. 9 as shown on plat of property of Morningside, as made by Dalton & Neves, Engineers, in December 1952, which plat is of record in the R. M. C. Office for said County and State in Plat Book "EE", at pages 2 and 3, reference to which plat is hereby made, said lot of land being described by metes and bounds, as follows, to wit:

BEGINNING at an iron pin on the Northeastern side of Spring Valley Road as shown on said plat at the corner common to Lots 8 and 9, and running thence N. 47-40 E. along the dividing line between lots 8 and 9, 186.0 feet to an iron pin at the corner of Lot 14; thence S. 42-20 E. along the dividing line between Lots 9 and 14, 125.0 feet to a stake at the corner of Lot 10; thence S. 47-40 W. along the dividing line between Lots 9 and 10, 184.5 feet to an iron pin on the Northeastern side of Spring Valley Road; thence along said Spring Valley Road N. 42-58 W. 125.0 feet to the place of beginning.

This property is subject to the restrictions and reservations set out in an instrument of writing dated January 20, 1953, and recorded in the R. M. C. Office for said County and State in Deed Book 470 at page 369, reference to which is hereby expressly made as a part of this conveyance, and is subject to the following additional restriction: "All tanks, barrels and containers for fuel oil shall be placed below the surface of the ground or concealed.
