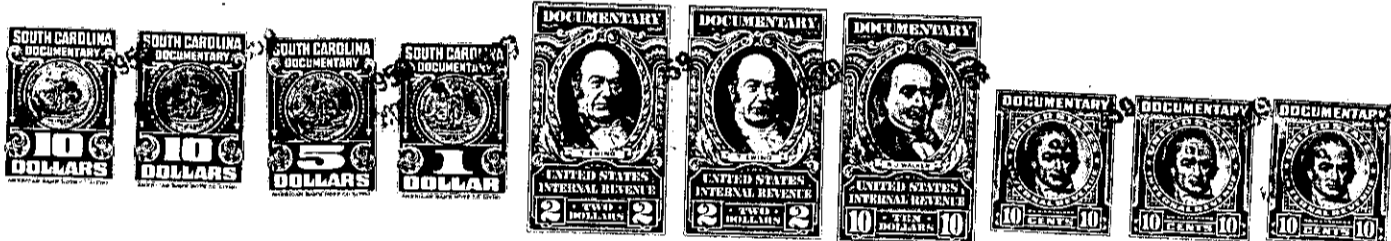
That W. H. Hamby in consideration of the sum of Thirteen Thousand and No/100 in the State aforesaid, DOLLARS,
