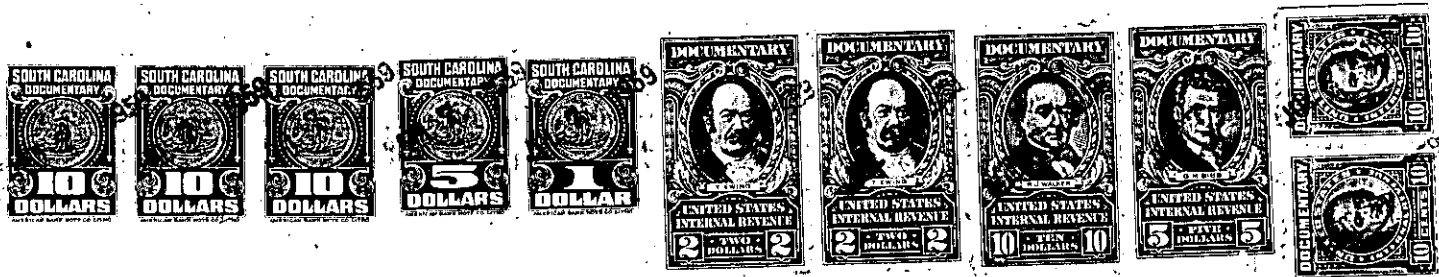
Know All Men by These Presents:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, known and designated as Lot No. 47, as shown on a plat of the subdivision of EXTENSION OF BROOKFOREST, recorded in the RMC Office for Greenville County in Plat Book QQ page 17, said lot having a frontage of 75 feet on the east side of Fairmont Avenue, a parallel depth of 140 feet, and a rear width of 75 feet.
