All that piece, parcel or lot of land situate, lying and being in the City of Greenville, Greenville County, State of South Carolina, on the southeastern side of East North Street Extension and being known and designated as Lot No. 15 of College Heights as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "P!, at Page 75 and having, according to said plat, the following metes and bounds, to-wit:
