Harding, his heirs and assigns: All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being shown as Lot No. 58 of Indian Hills, plat of which is recorded in the RMC Office for Greenville County in Plat Book QQ, Page 11, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Saponee Drive at joint front corner of Lots Nos. 57 and 58, and running thence with the line of said lots N. 80-30 E., 180 feet; thence S. 9-30 E., 90 feet; thence S. 80-30 W., 180 feet to an iron pin on Saponee Drive; thence with Saponee Drive N. 9-30 W., 90 feet to the point of beginning. BEGINNING at an iron pin on El Paso Drive at joint corner of lots Nos. 26 and 27, and running thence with the line of said lots S. 50-17 W., 250 feet; thence N. 39-43 W., 105.3 feet; thence N. 53-17 E., 250.5 feet to an iron pin on El Paso Drive; thence with El Paso Drive S. 37-43 E., 13 feet; thence still with El Paso Drive S. 39-43 E., 79.2 feet to the point of beginning.
