C. Kendrick, his Heirs and Assigns forever:

ALL that certain piece, parcel or lot of land, with the improvements thereon, lying, being and situate in the County of Greenville, State of South Carolina, Five Forks Community, being known and designated as Lot No. 5 in accordance with plat made for Grantor by J. Mac Richardson dated July 23, 1959, to be recorded in the R.M.C. Office for Greenville County and being more fully described in accordance with said plat, to-wit:
