BEGINNING at an iron pin on the Northwestern side of Glenrose Avenue at the joint front corner of Lots Nos. 49 and 50 as shown on the first plat hereinabove referred to, and running thence with the line of Lot No. 49 N. 63-07 W. 258 feet to an iron pin in the line of Lot No. 48; thence with the line of Lot No. 48 S. 27-55 W. 15 feet to an iron pin in the rear line of Lot No. 50; thence a new line through Lot No. 50 S. 63-05 E. 256 feet to an iron pin on the Northwestern side of Glenrose Avenue; thence with the Northwestern side of Glenrose Avenue N. 35-41 E. 15 feet to the point of beginning.

This conveyance is made subject to "Protective Covenants Applicable to Edgefield" recorded in the R.M.C. Office for Greenville County in Deed Book 576 at page 149; to "Amendment to Protective Covenants Applicable to Edgefield" recorded in the R.M.C.
