ASSIGNMENT AND AGREEMENT.

WHEREAS, NAILEY AND LOLLIS CONSTRUCTION COMPANY, INC., a
South Carolina Corporation of Easley, South Carolina, is indebted to STATE
BANK AND TRUST CO., WARE SHOALS, S. C., in the principal sum of Fifty-seven
Thousand (\$57,000.00) Dollars represented by its promissory note for said
amount dated August 28, 1959, payable in twelve (12) consecutive monthly
installments, the first eleven (11) installments being in the amount of Six
Hundred (\$600.00) Dollars each and the twelfth (12th) or final installment
being in the amount of Fifty Thousand Four Hundred (\$50,400.00) Dollars,
the first installment being due on the 28th day of September, 1959, and
continuing on the 28th day of each and every month thereafter until paid in
full, together with interest on the unpaid balance at the rate of five (5%)

WHEREAS, NALLEY AND LOLLIS CONSTRUCTION COMPANY, INC. has agreed to secure the payment of said indebtedness. NOW, THEREFORE,

KNOW ALL MEN BY THESE PRESENTS that NALTEY AND LOLLIS CONSTRUCTION COMPANY, INC., for value received, does hereby set over, transfer and assign to STATE BANK AND TRUST CO., WARE SHOALS, S. C., all its rights in and under the following Lease Agreements, to wit:

- (1) Lease Agreement entered into between NALIEY & LOLLIS
 CONSTRUCTION COMPANY, INC. and BALIENTINE GROCERY STORES,
 INC. dated May 5, 1955, relating to certain property located just
 outside the Corporate Limits of the City of Greenville, in Greenville
 County, South Carolina, known as the Jewell property. Said Lease
 Agreement is recorded in the RMC Office for Greenville County, S. C.,
 in Book 536, at Page 133.
- Lease Agreement between A. J. JEWELL and KINA M. JEWELL, as Lessors, and BALLENTINE GROCERY STORES, INC., as Lessees, dated April 6, 1955, covering certain property located near the Corporate Limits of the City of Greenville, in Greenville County, South Carolina, which said agreement was transferred and assigned to NALLEY & LOLLIS CONSTRUCTION COMPANY, INC. by BALLENTINE GROCERY STORES, INC. under the Lease Agreement dated May 5, 1955, hereinabove referred to, recorded in the RMC Office for Greenville County in Book 536, at Page 151.
