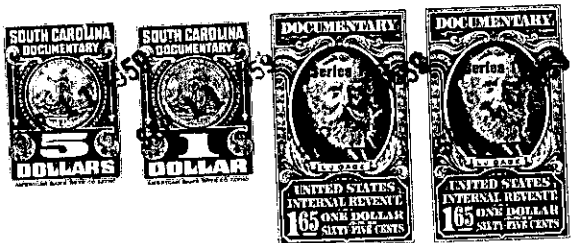

Know All Men by These Presents:

That I, Henry C. Harding, in the State aforesaid, in consideration of the sum of Three Thousand (\$3,000.00) DOLLARS, and assumption of Mortgage to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Roy Thomas Holder and Jane Louise Holder, their heirs and assigns: ALL that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being shown as Lot No. 9 on plat of Western Hills, Section 2, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book KK, Page 130, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Tucson Drive at joint front corner of Lots Nos. 9 and 10, and running thence with the line of said lots S. 0-15 W., 150 feet; thence S. 77-45W., 65.5 feet; thence N. 35-23 W., 201.9 feet; to an iron pin on Tucson Drive; thence with Tucson Drive S. 89-45 E., 181 feet to the point of beginning.

This conveyance is made subject to the right of way and set-back line shown on said plat, and to the restrictions applicable to Western Hills.
