Robert Earl Addington, his heirs and assigns forever:

All of that lot of land in the County of Greenville, State of South Carolina, in Bates Township at Slater, S. C. known as a portion of lot 1, lot 2, lot 10 and lot 11, Block E on plat of property of S. Slater & Sons in plat book K at page 63 and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin at the joint rear corner of lots nos. 11 and 12 with the corner of lot no. 1 on the western side of Third Street (formerly Lindberg St.) and running thence along Third Street N 31-41 E, 162 feet to an iron pin in the front line of lot no. 2; thence cutting through lot no. 2 and through lot no. 1 to and beyond the joint rear corner of lots nos. 9 and 10 S 89 W, 118.5 feet to an iron pin (which iron pin is 12 feet S 82-41 W, from the joint rear corner of lots nos. 9 and 10) thence S 7-19 E, 70 feet to an iron pin in the line of lot no. 11; thence S 12-15 E, 70.03 feet to an iron pin in the line of lot no. 12; thence along the line of lot no. 12, N 82-41 E, 6 feet to the point of beginning and being the same conveyed us by deed book 476 at page 491.
