James W. Crisp, his heirs and assigns forever:

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being at the southwesterly corner of the intersection of Forestdale Drive and Redcherry Lane, near the City of Greenville, S. C., and being shown as Lot No. 57 on the plat of Forestdale Heights as recorded in the RMC Office for Greenville County, S. C. in Plat Book KK, page 199, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Forestdale Drive, joint front corner of Lots Nos. 57 and 58, and running thence along the common line of said lots S 4-31 W 196.1 feet to an iron pin; thence S 85-45 E 80 feet to an iron pin on the westerly side of Redcherry Lane; thence along said Lane N 4-31 E 180.7 feet to an iron pin, corner of the intersection of said Lane and Forestdale Drive; thence around said intersection on a curve, the chord of which is N 40-29 W 21.2 feet to an iron pin on the southerly side of Forestdale Drive; thence along said Drive N 85-29 W 65 feet to an iron pin, the point of beginning.
