Know All Men by These Presents:

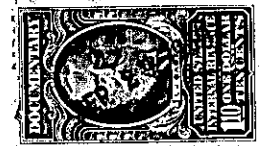
That I, WM. R. TIMMONS, JR., AS TRUSTEE,

the said R. O. NICHOLS, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Bates Township, Greenville  
County, State of South Carolina, near Travelers Rest, and being known and  
designated as Lot Number 22 as shown on a revised map of Lots Numbers 34  
through 47 of a subdivision known as Meadowbrook Farms, a plat of which is  
of record in the R. M. C. Office for Greenville County in Plat Book PP at  
Page 113, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northern side of Loraine Drive at the joint  
front corner of Lots 21 and 22 and running thence due North 190.4 feet to  
a point at the joint rear corner of Lots 21 and 22; thence N 87-00 W 90  
feet to a point at the joint rear corner of Lots 22 and 23; thence S 03-  
00 W 190 feet to a point on the Northern side of Loraine Drive at the joint  
front corner of Lots 22 and 23; thence with the Northern side of Loraine  
Drive S 87-00 E 100 feet to the point of beginning.
