to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Melton Walden, his heirs and assigns forever:

ALL that piece, parcel or lot of land in Gantt Township, being known and designated as Lot No. 59, of a subdivision known as Elizabeth Heights, as shown by a Plat thereof, dated May 1, 1956 by Madison H. Woodward, recorded in the R. M. C. Office for Greenville County in Plat Book KK, at Page 11, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on Satterfield Drive, joint front corners of Lots Nos. 58 and 59 and running thence along the line of said lots, N. 16-10 E. 150 feet to iron pin rear corner of Lots 40 and 41; thence running with rear line of Lot 40, N. 73-50 W. 75 feet to iron pin rear corner of Lot 60; thence running with line of said lot, S. 16-10 W. 150 feet to iron pin on Satterfield Drive; thence running with said Drive, S. 73-50 E. 75 feet to iron pin at point of beginning.

NO residence to costless than Seven Thousand Five Hundred (\$7,500.00) Dollars shall be erected on said lots; no residence shall be erected on any lot unless said lot has fifty (50) feet or more frontage; no residence shall be built on any lot nearer than thirty (30) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks; no business buildings shall be erected on any lot other than lots fronting on Staunton Bridge Road.
