Know All Men by These Presents:

That I, Robert H. Newman in consideration of the sum of Thirteen Hundred Eleven and 14/100 (\$1311.00) in the State aforesaid, and assumption of note and mortgage as set out below to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Frank A. Hiott, His Heirs and Assigns, forever:

All that piece, parcel or lot of land, with buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 13, Plat of Property of Nona Harris Squires, as per plat thereof recorded in the R. M. C. Office For Greenville County, South Carolina in Plat Book "S", page 151 and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Easterly side of Texas Avenud, joint front corner Lots 12 and 13 and running thence N. 71-0 E. 200 feet to an iron pin, joint rear corner Lots 12 and 13; thence S. 22-10 E. 67 feet to an iron pin, joint rear corner Lots 13 and 14; thence S. 71-0 W. 200 feet to an iron pin on the Easterly side of Texas Avenue, joint front corner Lots 13 and 14; thence along the Easterly side of Texas Avenue N. 22-10 W. 67 feet to an iron pin, the point of beginning.

As part of the consideration the Grantee agrees to assume and pay according to the terms that certain note and mortgage given to C. D. Wilson and Co. by the Grantor and recorded in the R. M. C. Office for Greenville County, the note and mortgage was in the original amount of \$9500.00 on which there is a balance due of \$8,188.86.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and His Heirs and Assigns forever.

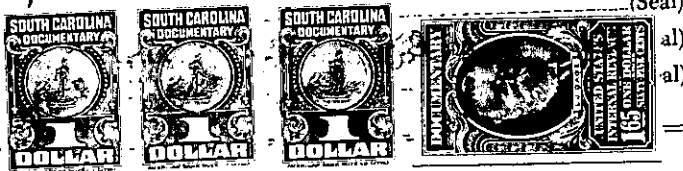
