E. GREENWOOD, HIS HEIRS & ASSIGNS FOREVER -All that piece, parcel or lot of land in Cleveland Township, Greenville County, State of South Carolina, being Lot No. 50 of a subdivision of D. B. Tripp land at River Falls, as per plat of said subdivision made by W. A. Hester, Surveyor, April 21, 1926, and recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book "G", Page 89, said lot containing one-fourth (1/4th) acre, more or less, and having the following metes and bounds, to wit: BEGINNING at a stake at joint front corner of Lots Nos. 24 and 25, and running thence S. 23 W., 313 feet, more or less, to a stake on a 30 foot road; thence with the said road in an Easterly direction, 140 feet, more or less, to a branch; thence with the meanders of sai d branch in a Northerly direction to the point of BEGINNING.
