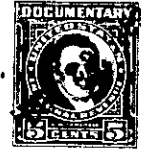

Know All Men by These Presents:

That Joe J. Faress in the State aforesaid, in consideration of the sum of Five Thousand Fifty-Three and 75/100 (\$5,053.75)--- DOLLARS, and assumption of mortgages described below, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Hershel L. Harrell, his heirs and assigns,

All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot 166, Section C. Woodfields, plat of which is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book W, page 133, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwesterly side of Pine Creek Drive, joint front corner Lots 167 and 166, said iron pin being 380 feet in an easterly direction from Hillside Lane; and running thence along Pine Creek Drive S. 56-32 E. 90 feet to an iron pin, joint front corner Lots 165 and 166; thence S. 33-28 W. 166 feet to an iron pin joint rear corner Lots 165 and 166; thence N. 56-32 W. 90 feet to an iron pin, joint rear corner Lots 166 and 167; thence N. 33-28 E. 166 feet to an iron pin, the point of beginning.

As a part of the consideration hereof, the grantee agrees to assume and pay, according to the terms thereof, those certain notes and mortgages given to Fidelity Federal Savings and Loan Association and R. M. Caine, on which there is a balance due of \$14,296.25 said mortgages being recorded in Mortgages Volume 795, page 188 and Mortgages Volume 786, page 560.

This is the same property conveyed to the grantor by deed recorded in Deeds Vol. 625, page 65. Grantor to pay 1959 taxes.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

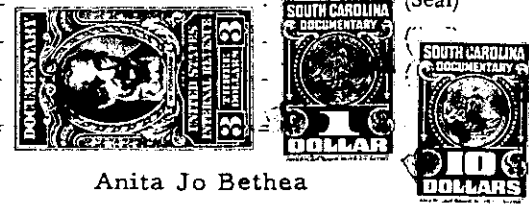
