That I, Rex L. Carter in consideration of the sum of One Thousand and No/100 (\$1,000.00) ... in the State aforesaid, DOLLARS,

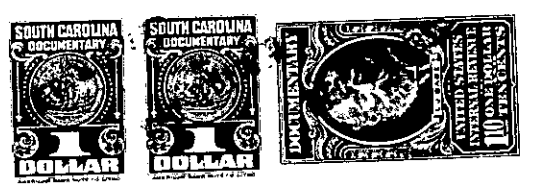
