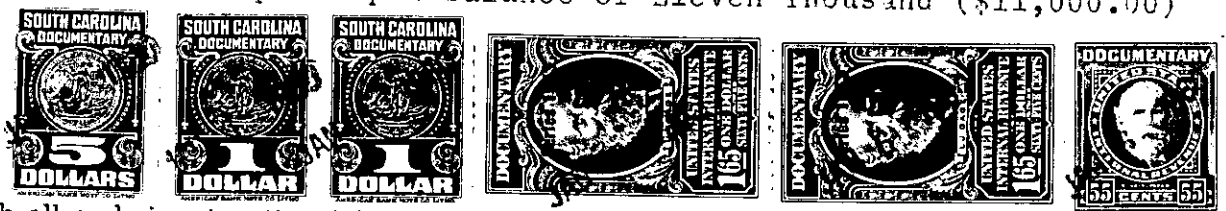
Know All Men by These Presents, That I (We) G. B. Nalley

in the State aforesaid, receipt for which is hereby acknowledged,
have granted, bargained, sold and released, and by these presents do grant, bargain, sell and
release unto the said Jasper P. Lesley, his heirs and assigns forever:
my one-half interest in -

"ALL that piece, parcel or lot of land in Fairview Township, Greenville
County, State of South Carolina, and in the Town of Fountain Inn on the
West side of Main Street, fronting on said street twenty-nine feet and
four inches, more or less, running back in parallel lines to property of
the C. & W. C. Railway Company, bounded by Main Street; lot formerly
belonging to A. G. Edwards and Brothers, now owned by P. D. Edwards;
C & W. C. Railway Company and lot of C. P. Armstrong. This being the
same lot of land upon which is located a two story brick mercantile building
known as the L. G. Hughes Building, now occupied by T. D. Sloan as a
grocery store. Being the identical lot conveyed to G. B. Nalley and
Jasper P. Lesley by deed dated December 6, 1958 and recorded in
Volume 613 at page 364 in the R. M.C. Office for Greenville County,
S. C."

ministrators, to warrant and forever defend all and singular the said premises unto the said
Jasper P. Lesley, his Heirs and Assigns, against Me (Us) and My (Our) Heirs and against every person whomsoever
lawfully claiming, or to claim, the same or any part thereof.
