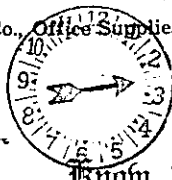

That I, M. W. Fore  
in consideration of the sum of Eleven Hundred Sixty & NO/100 (\$1,160.00) - - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ernest J. Delatore, his heirs and assigns forever:

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, being known and designated as Lots Nos. 41 and 42, of a sub-division known as Section A, of Englewood Estates, as shown by a Plat thereof, dated October 1951, recorded in the R. M. C. Office for Greenville County in Plat Book Y, at Page 140, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Beaumont Drive at joint front corners of Lots Nos. 40 and 41 and running thence along the line of said lot No. 40, S. 87-30 E. 150 feet to iron pin back corner of Lot 30; thence along the rear line of said lot Nos. 30 and 29, N. 2-30 E. 150 feet to iron pin at back corner of Lot 43; thence along the line of said lot No. 43, N. 87-30 W. 150 feet to iron pin on Beaumont Drive; thence running with said Drive, S. 2-30 W. 150 feet to iron pin at point of beginning.

NO residence shall be erected on lot costing less than Five Thousand (\$5,000.00) Dollars; no house is to be built nearer than fifty (50) feet to the Street; no temporary house is to be erected on said lot.

THIS deed is subject to any rights of ways now existing.

GRANTEE to pay 1960 taxes.



TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
