W. Norwood, Ir., property in plat book I at page 225, and having the following metes and bounds, to-wit:

Beginning at an iron pin in the joint lines of lots 2 and 3 on the Norwood plat, approximately 525 feet east of the joint rear corner of lots 2 and 3, and running thence N 28-29 W 292 feet to an iron pin thence along the Layton property 107 feet, more or less, to the center of a county road, called the Layton Road, thence along the center of said road in a southernly and then easternly direction 500 feet, more or less, thence 5 2-21 W 273 feet to an iron pin in the joint line of lots 2 and 3 on the Norwood plat, thence with said lot lines N 78-46 E 391 feet to the point of beginning.
