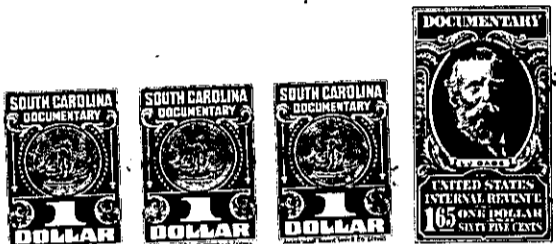
Know, All Men by These Presents:
