ALL that piece parcel or tract of land in Austin Township, Greenville County, State of South Carolina, being known and designated as TRACT NO. 5 containing 2.43 acres, according to a Survey made by J. C. Hill, Surveyor of the Estate of W. R. Corn, dated April 2, 1959 and revised June 26, 1959 and having the following metes and bounds, to wit:
