to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said JAMES T. McCARTER, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 80 of a subdivision known as McSwain Gardens, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book GG at Page 75, and having the following metes and bounds, to wit:

BEGINNING at a point on the Western side of McSwain Drive at the joint front corner of Lots 79 and 80 and running thence S 70-43 W 157.6 feet to a point at the joint rear corner of Lots 79 and 80; thence N 22-00 W 156.8 feet to a point at the rear corner of Lot 80; thence S 85-30 E 193.3 feet to a point on the Western side of McSwain Drive at the joint front corner of Lots 80 and 81; thence with the Western side of McSwain Drive S 11-42 E 80 feet to the point of beginning.
