Know All Men by These Presents:

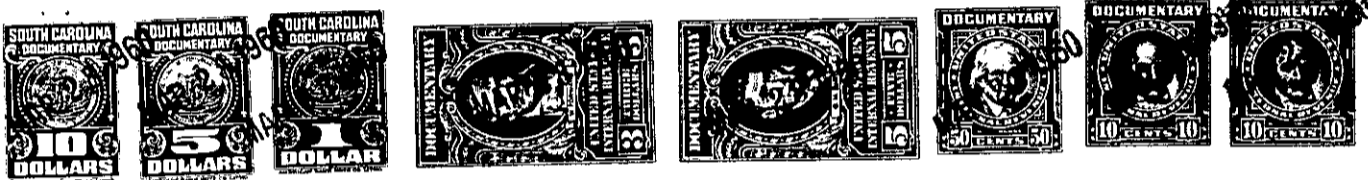
That Jack E. Shaw in the State aforesaid, in consideration of the sum of One Dollar and other considerations DOLLARS,

Chandler and Ellen P. Chandler, their heirs and assigns:

All that certain piece, parcel or lot of land, together with all buildings and improvements located thereon, situate, lying and being on the north side of E. Lee Road about one mile from the Town of Taylors and near the City of Greenville in the County and State aforesaid and having the following metes and bounds:

BEGINNING at an iron pin on the north side of E. Lee Road at the corner of property now or formerly of J. C. Wood and running thence N. 22-15 W. 208.72 feet to an iron pin; thence continuing along the same course 269.28 feet to an iron pin on the line of C. E.
