BALTZ

All that parcel or lot of land lying and being in the County of Greenville, State of South Carolina, being designated as Lot No. 48 as shown on Plat No. Three, Cherokee Forest, prepared by J. Mac Richardson, R.L.S., in January, 1959, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book QQ at pages 36 and 37, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the northern side of Roberta Drive, the joint corner with Lot No. 47 and running thence along the line of Lot No. 47 N. 15-58 E. 202.9 feet to an iron pin; thence S. 81-27 E. 100.24 feet to an iron pin; thence along the line of Lot No. 49 S. 15-58 W. 210 feet to an iron pin on the northern side of Roberta Drive; thence with the northern side of Roberta Drive N. 74-02 W. 100 feet to an iron pin, the point of beginning.

The foregoing lot is subject to a drainage easement along the rear line of said lot as more fully shown on the plat above referred to.
