RICHARD C. RUDISILL, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, near the City of Greenville; and being known and designated as Lot Number 67 of a subdivision known as McSwain Gardens, a plat of which is of record in the R.M.C. Office for Greenville County in Plat Book GG at Page 75, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southwestern side of Shannon Drive at the joint front corner of Lots 66 and 67 and running thence S 64-45 W 241.7 feet to a point at the joint rear corner of Lots 66 and 67; thence N 13-55 W 9.8 feet to a point; thence N 02-55 W 70.6 feet to a point at the joint rear corner of Lots 67 and 68; thence N 53-53 E 192 feet to a point on the Southwestern side of Shannon Drive at the joint front corner of Lots 67 and 68; thence with the Southwestern side of Shannon Drive S 49-19 E 13.1 feet to a point; thence continuing with the Southwestern side of Shannon Drive S 39-12 E 78.2 feet to a point; thence still continuing with the Southwestern side of Shannon Drive S 25-15 E 23.7 feet to the point of beginning.
