in the State aforesaid, in consideration of the sum of Twenty Seven Hundred Ninety-five and no/100 -----DOLLARS,

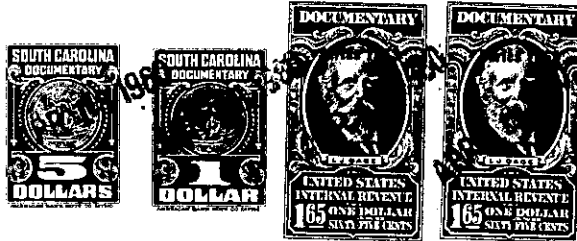
