All of that lot of land in the County of Greenville, State of South Carolina in Bates Township, near Travelers Rest known as lot no. 12 on plat of Montevideo, recorded in plat book FF at page 439 and having the following metes and bounds, to-wit:

Beginning at an iron pin on the eastern side of West Scenic Drive, at the corner of lot no. 11 and running thence along said lot N 75-35 E, 238.3 feet to an iron pin at the rear of lot no. 21; thence N 2 W, 50 feet to an iron pin at the rear of lot no. 13; thence with said lot N 86-30 W, 245 feet to an iron pin on the eastern side of West Scenic Drive; thence with said Drive in a southeasterly direction a curve of 20°, 125 feet to the point of beginning and being a portion of the property conveyed to us in deed book 538 at page 32.
