All that certain piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina situate, lying and being on the South side of University Ridge, formerly Choice Avenue, being known and designated as Lot No. 6 on Plat of the property of Furman University by F. G. Rogers as recorded in the R. M. C. Office for Greenville County in Plat Book A, Page 415 and, according to said plat, having the following metes and bounds, to-wit:

BEGINNING at a point on University Ridge said point being the joint front corner of Lots Nos. 5 and 6 and running thence with University Ridge N. 89-40 W. 85 feet to a point, the joint front corner of Lots 6 and 7 on said plat; thence due South 250 feet to a stake; thence S. 89-40 E. 85 feet to a stake; thence due North 250 feet to a point on University Ridge, the beginning corner.
