Baker, her heirs and assigns forever:

All that certain lot of land on the western side of Lanneau Drive being known and designated as the northern 37 1/2 feet of lot 58 and the southern 25 feet of lot 59 of a sub-division known as Lanneau Drive Highlands as shown on the plat thereof made by Dalton & Neves in August 1937 and recorded in Plat Book D, page 289, and having the following metes and bounds:

BEGINNING at an iron pin on the western side of Lanneau Drive in the front line of lot # 58 which point is 12 1/2 feet north from the corner of lot 57, and running thence along the western side of Lanneau Drive N. 10-11 E. 62 1/2 feet to an iron pin in the center of the front line of lot 59; thence on a line across the middle of lot 59 N. 79-49 W. 150 feet to an iron pin in the center of the rear line of said lot 59; thence S. 10-11 W. 62 1/2 feet to an iron pin in the rear line of lot 58, which point is 12,1/2 feet north of the corner of lot 57; thence on a line across lot 58 S. 79-49 E. 150 feet to an iron pin on the western side of Lanneau Drive, the point of beginning; this being the same lot conveyed to me by Basil C. Willingham by deed dated 16 July 1953 and recorded in the R. M. C. Office for Greenville County in deed book 482 at page 119.
