and to construct and maintain in, upon and through said premises, in a proper manner, a pipe line or lines, air vents, blow off connections manholes and other necessary apparatus incident thereto, using the necessary appliances and machinery for such work for the purpose of conveying water through the premises above described, together with the right at all times to enter upon said premises for the purpose of inspecting said line or lines and making necessary repairs and alterations thereon, together with the right to cut away and keep clear of said pipe line or lines all trees and other obstructions that may in any way endanger or interfere with the proper operation of or access the same.
It is understood and agreed that the right of way to be used under this contract during construction is to be seventy-five feet is width throughout the entire length which is approximately 527.1 feet, and the damage, which THE CITY OF GREENVILLE SOUTH CAROLINA, is to be liable for during construction, is to be confined to this strip and nothing beyond. It is further understood that the owner is to have the right to cultivate and use this right of way strip of land provided such use there of shall not interfere with the proper maintenance and free access to the pipe line or lines to be installed under this agreement. No build ings or other structures shall be placed on said right of way nearer than
The payment above specified covers compensation for the easement or right of way, and also covers all claims for damages, in cluding crops growing on the right of way during the year 19-60-, along said right of way resulting from construction of the pipe line or lines to be laid.
It is further agreed that in case of future damages to property or crop, due from an accident on the pipe line that THE CITY OF GREENVILLE shall pay all damages.  The undersigned agrees to release and give to THE CITY OF GREENVILLE, SOUTH CAROLINA, actual physical possession of the premises above described not later than the 12th day of April 1960.
