County State of South Carolina, located in Parker School District #8-A on the South side of Decatur Drive, being lot No. 9 as shown on plat of survey made by W. J. Riddle, Surveyor, on March 17, 1937 of subdivision of property belonging to D.L.Bramlett, on west side of Parker Road--said plat having been recorded in the RMC Office for Greenville County in Plat Book I at page 139--with metes and bounds as follows:
