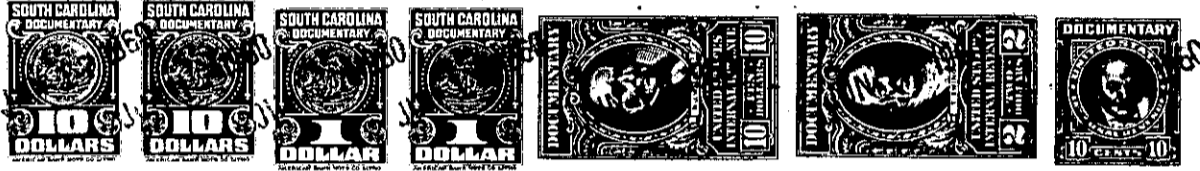
Know All Men by These Presents:

That I, L. A. Moseley in the State aforesaid, in consideration of the sum of Ten Thousand, Nine Hundred Fifty and No/100 -----DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. B. and Sallie M. Greer, their heirs and assigns forever;

ALL THAT CERTAIN piece, parcel or lot of land, situate, lying and being on the southern side of Waverly Court in that area recently annexed to the City of Greenville, Greenville County, known and designated as Lot No. 25, on a Plat of Augusta Heights, made by Dalton & Neves, Engineers, April, 1941, recorded in the R.M.C. Office of Greenville County in Plat Book "K", at Page 88, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Waverly Court, being the joint front corner of Lots 25 and 26, and running thence with the line of Lot 26 S. 26-38 E. 168 feet to an iron pin on the northern side of a 12 foot alley; thence along the northern side of said alley S. 62-20 W. 60 feet to an iron pin; thence with the line of Lot No. 24 N. 26-38 W. 168 feet to an iron pin on the southern side of Waverly Court; thence running along the southern side of Waverly Court N. 62-20 E. 60 feet to the beginning corner.

This being the same property as was conveyed to the Grantor herein by deed of Burton S. Anderson, recorded in R.M.C. Office of Greenville County in Deed Book 648, at Page 318, 16th day of April, 1960.
