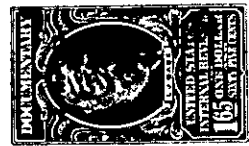

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Milton Mahaffey, his heirs and assigns forever:

All that certain piece, parcel or tract of land, with improvements thereon, lying, being, and situate in the town of Mauldin, County of Greenville, State of South Carolina, being composed of portions of lots 12 and 13, according to plat made by J. W. Riddle for C. A. and Jessie M. Rice, dated June 15, 1939, and recorded in plat book J at page 153 in the R. M. C. Office for Greenville County, and being more fully described accordingly:

Beginning at an iron pin on the northern side of Butler Road 5 feet east of the former point dividing lots 11 and 12, and being joint front corner with property, of even date as conveyed by grantors to Calvin Kellett, and running thence along the Calvin Kellett property line in a northern direction 109 feet to an iron pin; thence S. 35-40 E, 135.5 feet to an iron pin on the northern side of Butler Road; thence along Butler Road N 87 W, 55.5 feet to an iron pin, being the point of beginning.

This being a portion of the property as conveyed to grantors by deed recorded in deed book 546 at page 343 in the R. M. C. Office for Greenville County.
