All that piece, parcel or lot of land in Bates Township, Greenville County, State

of South Carolina, known as a portion of the land conveyed to W. H. Vest  
by deed from Charley Langly adjoining of C. C. Vest, City Water  
Company and Batson Bros., beginning at an iron pin at the northwest  
corner; thence running S  $63/4$  W 11.28 Chs. to a concrete corner;  
thence N  $5-6 \frac{1}{8}$  E, 3.00 Chs. to an iron pin; thence N 2 E, 9.05  
Chs. to an iron pin; thence N 70 W, 1.62 to the beginning corner  
and contains two (2) acres, more or less. Being the same property  
conveyed to me in the name of Clara Bell Robinson by W. H. Vest by  
deed dated February 6, 1937, and recorded in R.M.C. office for  
Greenville County in Deed Volume 193 at page 217.

All that piece, parcel or lot of land in Bates Township, Greenville  
County, State of South Carolina, known as a part of the land conveyed
