James W. Kidd and Sara S. Kidd, their heirs and assigns forever:

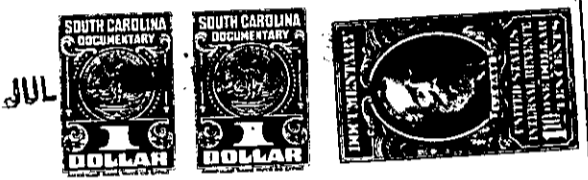
