KNOW ALL MEN BY THESE PRESENTS That PIEDMONT AND NORTHERN RAILWAY COMPANY, a corporation duly organized and existing under and by virtue of the laws of the State of South Carolina, in consideration of the sum of Two Thousand Thirty-four and no/100 (\$2,034.00) Dollars to it in hand paid at and before the sealing of these presents by THE BLACK HAWK CORPORATION, a corporation duly organized and existing under and by virtue of the laws of the State of South Carolina, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said The Black Hawk Corporation, its successors and assigns, all that certain strip or parcel of land situate, lying and being near White Horse, in Greenville County, South Carolina, and more particularly described as follows:
