to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

JACK T. BALLEW and JONES C. BRYANT, their heirs and assigns forever,

ALL that piece, parcel or lot of land in Cleveland Township, Greenville County, State of South Carolina, being known and designated as Lot No. 6 as shown on Plat of property of Clara Bates Turner according to Survey made by Dean C. Edens, May 22, 1950 and having the following metes and bounds, to wit:

BEGINNING at an iron pin fifteen feet from the Right-of Way of the Greenville Water Line and running thence along the joint line of Lots 5 and 6, South 32 East 342 feet to the center of Saluda River; running thence along Saluda River South 86 East 96 feet to a point; running thence North 35 West 380 feet to an iron pin fifteen feet from the Right-of Way of the Greenville Water Line; thence along said Right-of-Way, North 87 West 60 feet to the points of beginning:

This property is sold subject of the restrictions set forth below and any and all other easements, restrictions and conditions recorded against said property.

This property shall be used for residential purposes only.

2. Septic tanks for sewer disposal are to be used exclusively. A 25-foot right-of-way is reserved along the Greenville Water Line

Right of way for the construction of a road.
