All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Gantt Township, being known and designated as Lot No. 26 of a subdivision known as Greenfields, Section 3, according to a plat thereof prepared by C. C. Jones, C. E., October, 1954, and recorded in the R. M. C. Office for Greenville County in Plat Book GG at Page 93, and having, according to said plat, the following metes and bounds, at Page 93, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western edge of a dul-de-sac at the northern end of Dolphin Street, the joint front corner of Lots Nos. 25 and 26, and running thence along the joint line of said lots, being the center line of a 10 foot drainage easement, S. 79-10 W. 99.2 feet to an iron pin at the joint rear corner of said lots; thence N. 11-55 W. 177.2 feet to an iron pin; thence N. 74-15 E. 70.6 feet to an iron pin at the rear corner of Lot No. 27; thence along the line of that lot, S. 35-45 E. 143.6 feet to an iron pin on the northern edge of said cul-de-sac at the northern end of Dolphin Street; thence along the curvature of said cul-de-sac, the chord of which is S. 17-09 W. 60 feet to the beginning corner.
